## CALIFORNIA UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING ACT INFORMAL BIDDING PREQUALIFICATION QUESTIONNAIRE JANUARY 1, 2024 – DECEMBER 31, 2024

On May 1, 2018, the Corona-Norco Unified School District ("District") Board of Education adopted a resolution making the District subject to the California Uniform Public Construction Cost Accounting Act ("CUPCCAA"), Public Contract Code sections 22000 et seq. Accordingly, and pursuant to the provisions of Public Contract Code section 22034 and the criteria promulgated by the California Uniform Construction Cost Accounting Commission, contractors interested in bidding on District public works projects with an estimated cost of \$200,000 or less are required to complete and submit this Informal Bidding Prequalification Questionnaire in order to be placed on the District's Informal Bidding Contractors List in effect from January 1, 2024 until December 31, 2024. In November, the District will again issue an invitation for interested contractors to complete and submit an Informal Bidding Prequalification Questionnaire in order to be placed on the District's Informal Bidding Contractors List in effect during the 2024 calendar year, with a similar invitation issued annually thereafter. All contractors on the District's Informal Bidding Contractors List for the category of work being informally bid will be notified of the opportunity to bid as those opportunities arise. The District makes no guarantee, either express or implied, that submission of an Informal Bidding Prequalification Questionnaire will lead to a contract award.
