School Description and Mission Statement (School Year 2019-20)

Listen, Learn, Persevere, and Achieve

At Coronita Elementary School, staff, students, families, and community members are committed to developing and challenging all life-long learners academically, creatively, and socially in an emotionally safe environment.

Coronita Elementary School is one of thirty-two elementary schools in the Corona-Norco Unified School District. We are on a traditional track. Coronita is located on a large campus in the western section of Corona. Our student population is culturally and ethnically diverse with approximately 89% Hispanic, 5.5% white, and 3.3% African-American. Coronita is a Title 1 School with approximately 89% free and reduced lunch, 89% socio-economically disadvantaged and 39% English Learners. Class sizes range from up to 32 in primary 34 in upper grades.

Coronita Elementary employs one Principal, a half-time Assistant principal, 20 teachers, 1 Special Education Resource teacher, and 2 Teachers-on-Special Assignment. Additional support is provided by three Special Education aides, three bilingual aides, one library clerk, and one computer clerk, a health clerk, and a part-time band teacher. In addition, we have a Speech Pathologist and a half-time School Psychologist. One Temporary Specialist works with pre-kindergarteners. Other Classified employee positions include one secretary, two full-time clerk typists, three custodians, three cafeteria workers, and six noon time supervisors. To extend our instructional day we provide the After School Expanded Learning to our students, which provides a homework block, a tutoring block, enrichment blocks, and snack. The After School Expanded Learning program provides these services daily, until 6:00 PM. We employ one program lead and four aides to fulfill these requirements.

All students at Coronita Elementary receive standards-based instruction utilizing the district adopted core curriculum. Kindergarteners receive 212 instructional minutes, first - third graders receive 307 instructional minutes and grades four-six receive 317 instructional minutes. Teachers are provided with weekly early-release days to collaborate and create grade-level goals, examine grade-level data, discuss first best instructional strategies and plan intervention and enrichment as we work as a team for the benefit of our students.

Quality, Currency, Availability of Textbooks and Instructional Materials (School Year 2019-20)

Year and month in which data were collected: September 3, 2019

All textbooks used in the core curriculum are aligned to the California State Standards. Instructional materials are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. The district follows the State Board of Education's six-year adoption cycle for core content materials (English/language arts, math, science, and social science).

On Tuesday, September 3, 2019, the Corona-Norco Unified School District's Board of Education held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Education adopted Resolution No. 46 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, and (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts.

In addition to core subject areas, districts are required to disclose in their SARCs the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2019-20 school year, Corona-Norco Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or instructional materials to use in class and to take home. These materials complied with the state's content standards and curriculum frameworks.

School Facility Conditions and Planned Improvements (Most Recent Year)

School Facilities & Maintenance

The district takes great efforts to ensure that all schools are clean, safe, and functional through proper facilities maintenance and campus supervision. Coronita Elementary School's original facilities were built in 1961; ongoing maintenance and campus improvements ensure facilities remain up to date and provide adequate space for students and staff. District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed in a timely manner. A work order process is used by school and district staff to communicate non-routine maintenance requests. Emergency repairs are given the highest priority. In the last 12 months, the following improvements have been completed:

- Addition of water-wise garden
- Addition of a butterfly garden
- Addition of interactive mural
- Painting on the playground for math programs (Five Frames & Ten Frames)

Every morning before school begins, the custodian inspects facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. One day custodian and two evening custodians are assigned to Coronita Elementary School. The day custodian is responsible for:

- Classroom cleaning
- Cafeteria setup/cleanup
- General grounds maintenance
- Groundskeeping
- Restroom cleaning

Restrooms are checked regularly throughout the day for cleanliness and subsequently cleaned as needed. The evening custodians are responsible for:

- Classroom cleaning
- Office area cleaning
- Restroom cleaning
- Lunch area cleaning
- Evening event setup/cleanup
- Staff room cleaning

The principal communicates with custodial staff daily concerning maintenance and school safety issues.

Facilities Inspection

The district's maintenance department inspects Coronita Elementary School on an annual basis in accordance with Education Code §17592.72(c)(1). Coronita Elementary School uses a school site inspection survey to identify unsafe or hazardous conditions and facility improvement needs. The most recent school inspection took place on Monday, November 26, 2018. Deficiencies noted in the school inspection survey were corrected immediately by the district's maintenance department. During the fiscal year 2018-19, all restrooms were fully functional and available for student use at the time of the inspection.

Types of Services Funded (Fiscal Year 2018-19)

For the 2015-16 school year, Corona-Norco Unified School District spent an average of \$9,901 of total general funds to educate each student (based on 2015-16 audited financial statements and in accordance with calculations defined in Education Code §41372).
