School Description and Mission Statement (School Year 2020-2021)

Eleanor Roosevelt High School (ERHS) is a comprehensive high school located in the city of Eastvale, California, which is less than 10 minutes south on the 15 freeway from the city of Ontario. Situated on 58 acres of property, ERHS houses enough classrooms to hold 4700 students and is one of the most impressive facilities in the state of California. During the 2019-2020 school year, Eastvale STEM (ESTEM) Academy's doors were opened. This new state of the art specialized building was an expansion of ERHS to accommodate increased student enrollment. The STEM Academy campus adopts the school within the school model with its full array of amenities including front office, administration building, counseling center, cafeteria, specialized labs and 21st century learning classrooms.

Mustang pride is evident when visiting our campuses from the morale of the students and staff to the pristine care that is given to maintain a clean and safe campus, despite being one of the most used facilities in our county, our classrooms, office, cafeteria, gymnasium, weight room, auditorium, playing fields, and parking lots are well maintained. ERHS currently serves approximately 4,634 students and is located in a relatively new and expanding community of residential homes, strip malls, and growing retail centers.

When you walk on to ERHS campuses, you will quickly notice the diversity of the student population because ERHS is the most diverse school in the Corona Norco Unified School District (CNUSD). The population of Eastvale is diverse in ethnicity, educational levels, and socioeconomic status and consists of predominantly middle-class families. CNUSD has been highlighted by the Broad Foundation and the distinguished research organization Ed Trust West for being one of the most effective school districts in the United States in reducing the achievement gap that exists between African American students, Latino students, and other student subgroups. ERHS was also highlighted in a study by the Sacramento County Office of Education which stated that ERHS is doing the best job of all high schools in the state of California in reducing the achievement gap with African American Students in English language arts and the fourth best with Latinos. For the 2020-2021 school year, CNUSD was awarded the prestigious Golden Bell Award for its work with foster youth here at ERHS. Foster youth are often the "invisible" under-served population, and it has been ERHS' mission to help close this invisible achievement gap by making our foster students feel they are a part of a community that cares and is invested in their success. The All-Stars program is a comprehensive academic and social/emotional program serving the needs of today's foster youth. The program includes academic supports, on-campus programs, mentoring, district and community outreach, higher education planning, resources and building meaningful relationships with this at-risk population.

Our Mustang family is proud to serve the largest amount of student subgroups in the district. Our school site provides a warm, stimulating environment where students are actively involved in learning academics as well as positive values. Students receive a standards-based, challenging curriculum by dedicated professional staff based on the individual needs of the students. Ongoing evaluation of student progress and achievement helps us refine the instructional program so students can achieve academic proficiency.

Quality, Currency, Availability of Textbooks and Other Instructional Materials (School Year 2020-2021)

All textbooks used in the core curriculum are aligned to the California State Standards. Instructional materials are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. The district follows the State Board of Education's six-year adoption cycle for core content materials (English/language arts, math, science, and social science).

On Tuesday, September 1, 2020, the Corona-Norco Unified School District's Board of Education held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Education adopted Resolution No. 46 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, and (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts.

In addition to core subject areas, districts are required to disclose in their SARCs the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2020-21 school year, Corona-Norco Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or instructional materials to use in class and to take home. These materials complied with the state's content standards and curriculum frameworks.

School Facility Conditions and Planned Improvements

The district takes great efforts to ensure that all schools are clean, safe, and functional through proper facilities maintenance and campus supervision. Eleanor Roosevelt High School's original facilities were built in 2006; ongoing maintenance and campus improvements ensure facilities remain up to date and provide adequate space for students and staff. District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed in a timely manner. A work order process is used by school and district staff to communicate non-routine maintenance requests. Emergency repairs are given the highest priority. In the last 12 months, the following improvements have been completed:

- Addition of sixteen portable classrooms
- Redo football field and track
- Continued construction of Eastvale STEM Academy (completed 2018-19 year)

Two security fences placed on the emergency access roads securing the perimeter of the school

Every morning before school begins, the custodians inspect facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. Eight-day custodians and nine evening custodians are assigned to Eleanor Roosevelt High School. The day custodians are responsible for:

- Classroom cleaning
- Cafeteria setup/cleanup
- Groundskeeping
- Office area cleaning
- Restroom cleaning

.For the 2018-2019 school year, we initiated monthly maintenance reports to risk management.

Restrooms are checked regularly throughout the day for cleanliness and subsequently cleaned as needed. The evening custodians are responsible for:

- Classroom cleaning
- Office area cleaning
- Restroom cleaning

The assistant principal over facilities meets daily & communicates with head custodian daily concerning maintenance and school safety issues.

Facilities Inspection

The district's maintenance department inspects Eleanor Roosevelt High School on an annual basis in accordance with Education Code §17592.72(c)(1). Career Technical Education Programs (School Year 2019-2020)

Students in grades nine through twelve receive counseling from school personnel regarding career paths and courses of study. During their freshman year, students meet with the Career Center Advisor and Counselor to discuss their four-year academic plan and are introduced to technical and career education programs; the Career Center Advisor and Counselor meets at least once a year with each student to follow-up on their progress in meeting graduation requirements and career objectives. All career and technical education (CTE) courses comply with state-adopted content standards and are integrated into the student's four-year academic plan as elective courses. California Colleges is an online, interactive career resource that provides students with interest inventories, matches students with careers they might find interesting, and provides college and career planning tools that integrate the 15 California Career Technical Education industry sectors. Centennial High School students create individual Learning Plans and complete online portfolios demonstrating college and career readiness. Components of this plan include child abuse reporting procedures, teacher notification of dangerous pupil procedures, disaster response procedures, procedures for safe arrival and departure from school, sexual harassment policy, and dress code policy. In response to the COVID 19 pandemic, in addition to the comprehensive school site safety plan all sites were required to develop a school opening safety plan following state and local county health and safety guidelines. Both plans were reviewed by the school safety committee and school site council and updated in October 2020, and discussed with school staff on October 26, 2020.

Eleanor Roosevelt High School offers support to new and veteran teachers through peer coaching and mentoring. Instructional aides are provided targeted training focused on teaching strategies and curriculum content. Substitute teachers are invited to participate in designated staff development activities. All staff are encouraged to attend professional workshops and conferences. Classified support staff receive job-related training from department supervisors and district representatives.

During the 2019 - 2020 and the 2020-2021 school year, there has been a shift in the way Professional Learning has been offered and the focus. This change was in response to the needs of the stakeholders across the district.

1. Total number of districtwide sessions – CNUSD switched from days to sessions. CNUSD had 321 professional learning titles with 839 sessions lasting from 1 hour to 6 hours depending on the training and the setting. This year in April, in response to the pandemic, the trainings all moved to online model. CNUSD logged 19,312 staff members attending sessions throughout the 19-20 school year.
