# Corona-Norco Unified School District Emergency/Quarantine Independent Study Agreement 2021-2022 School Year

This agreement serves the purpose of attendance verification should a student encounter an unexpected emergency or need to be quarantined due to COVID-19.

#### **Guidelines:**

- This agreement is effective between July 1, 2021, and June 3, 2022.
- Students participating in independent study may earn a minimum of 3 days of
  attendance credit depending upon their level of work completion and number of days
  absent due to emergency or quarantine. Actual dates for independent study will be
  recorded in the Q student information system. Credit yielded from independent study will
  be a fraction of the regular credit for the course since students participating in
  independent study will be returned to in-person instruction.
- The objective of independent study is to maintain continuity in student learning during an
  emergency or quarantine. Methods of study can include, but are not limited to, reading,
  writing, electronic activities, projects, etc. Credit for independent study assignments will
  mirror the assignment of credit for assignments completed in the classroom.
- All students will be provided resources and materials to use, which may include, but are
  not limited to, devices, wi-fi hotspots, paper/pencil, textbook(s), and the use of electronic
  platforms such as Google Classroom and Canvas.
- All students may access supports with teachers, counselors and others while
  participating in independent study. Academic and other supports will be provided as
  necessary.
- No student shall be required to participate in independent study. Students with emergencies or who are in quarantine who do not participate will be marked with an unexcused absence.

## **During Leave of Absence:**

• The student will receive work from the teacher(s) and complete that work for each school day of absence.

### **Upon Return from Absence:**

- Students may submit assignments anytime between the day work is assigned and the date the student returns to school. All assignments are due upon the first day a student returns to school.
- Students should submit assignments directly to the teacher(s) either by hand or through electronic means.
- Teacher(s) will evaluate assignments through oral, written, graded or other means. Grades will be reported via Q Parent and Student Connect.
